### 1. Purpose

As per the 2020 Michelin Le Mans Cup Sporting Regulations, certain aspects related to the application of the Series regulations -including technical regulations - have been entrusted to the Committee. The Committee is either named "Committee" or the "MLMC Committee" in the Sporting Regulations.

### 2. Composition

For the 2020 season, the Committee is composed of:

- Vincent Beaumesnil
- Eduardo Freitas
- Gérard Neveu
- Cédric Vilatte
- Thierry Bouvet or a Technical Delegate

### 3. Principle of operation

Any Competitor, manufacturer or driver wishing to obtain a clarification on a point of the regulations between two Competitions, may submit the matter to the Committee.

Any interpretation given by the Committee cannot be opposable to the sporting authority represented by the Race Director and the Panel of Stewards.

**Any decision taken by the Michelin Le Mans Cup Committee is not subject to appeal.**

## DECISION (CONTINUED)

To do so, the Competitor or driver must send the Committee a request, duly motivated, clearly specifying the points on which they are requesting an interpretation.

### 4. Applicable regulations

The Committee may clarify or amend provisions of the regulations applicable to the Series. For the avoidance of doubt, these regulations are:

- 2020 Michelin Le Mans Cup Sporting Regulations
- 2020 Technical Regulations for LMP3 Prototypes
- Applicable Technical Regulations for FIA GT3 cars

### 5. Field of competence

The Committee is competent for, without its competence being limited to, the following matters, as described in the 2020 Michelin Le Mans Cup Sporting Regulations:

- Amend the Sporting Regulations (Art. 1.2.6) and applicable Technical Regulations
- Rule on car model change (Art. 3.6)
- Rule on the admissibility of innovative cars (Art. 3.2.4)
- Design and amend equivalence systems, including the BOP for GT3 cars (Art. 6.3)
- Adjust the Pitstop Handicap rules (Art 6.3.5)
- Adjust the tyre allocated quantities (Art 6.5.6)
