The Stewards notify all Competitors and all Officials of the following:

### **Pit Stop Reference Time:**

In accordance with Article 12.4.2 of the 2024 MLMC Sporting Regulations, the Pit Stop Reference Time for the Spa event is defined as **160** seconds.

### **Time Penalties**

In accordance with Article 7.5.2 of the 2024 MLMC Sporting Regulations, the time penalty which will be applied in the case of any Drive Through or Stop and Go penalty notified close to the end of, or after, the races at this competition will be as follows:

**Drive Through penalty** will be converted to **30 seconds** added to the elapsed time of the car.

**Stop-and-Go penalty** will be converted to **35 seconds plus the prescribed stop time** added to the elapsed time of the car.

### **Corrections to Appendix 1:**

The Dates of the Event are 21st – 24th August 2024.

#### Article 7

The length of one lap is 7.004 km.


### **Parc Fermé**

The Parc Fermé will be situated in the Brown Paddock – Interior of La Source Hairpin.




