The Stewards notify all Competitors and all Officials of the following:

Pit Stop Reference Time:

In accordance with Article 12.4.2 of the 2024 MLMC Sporting Regulations, the Pit Stop Reference Time for the Mugello event is defined as **105 seconds**.

Time Penalties

In accordance with Article 7.5.2 of the 2024 MLMC Sporting Regulations, the time penalty which will be applied in the case of any Drive Through or Stop and Go penalty notified close to the end of, or after, the races at this competition will be as follows:

Drive Through penalty will be converted to **30 seconds** added to the elapsed time of the car.

Stop-and-Go penalty will be converted to **35 seconds plus the prescribed stop time** added to the elapsed time of the car.
