3. Pit Stop Reference Time:

In accordance with Article 12.4.2 of the 2025 MLMC Sporting Regulations, the Pit Stop Reference Time for the Le Castellet event is defined as **160** seconds.

4. Time Penalties

In accordance with Article 7.5.2 of the 2025 MLMC Sporting Regulations, the time penalty which will be applied in the case of any Drive Through or Stop and Go penalty notified close to the end of, or after, the races at this competition will be as follows:

Drive Through penalty will be converted to 35 seconds added to the elapsed time of the car.

Stop-and-Go penalty will be converted to **40 seconds plus the prescribed stop time** added to the elapsed time of the car.

The Stewards confirm the decision of the MLMC Committee that from the technical analysis of driver Julien Lemoine, there will be an additional 19 seconds imposed on the Pit Stop Handicap Time for car 84 at his event.
