The Stewards, having received a report from the RTLM Race Director, having examined video evidence, have considered the following matter, determine the following:

N° / Driver: 21 / Gino-Generoso FORGIONE
Competitor: AF CORSE
Session: Race 2
Time (fact): 10:12:41
Fact: Unsporting behaviour.
Offence: Breach of Article 12.2.1 m) of International Sporting Code
Decision: Fine of 1000 euros plus 2 penalty points (balance of 6 for the 2025 season)

In accordance with Article 12.8.1 of the ISC, fines shall be paid within forty-eight hours of their notification by means of bank transfer to LMEM, in accordance with Article 7.2.5 of the RTLM Sporting Regulations.

Reason: Following the incident in which car#23 made contact with car#21, forcing both cars to spin and stop, the driver of car#21 left his car, went to car#23, punched the car window and kicked the door. Marshals tried to pull the driver away from the car but the driver resisted and tried to break free.

The Stewards heard from the driver who immediately apologized for the behaviour and thanked the marshals for calming him down.

The Stewards determined that the driver clearly demonstrated unsportsmanlike behaviour and also acted in a manner that brought the Series into disrepute.

The Stewards noted that the driver, without prompting, was immediately apologetic and therefore determined that the driver receive a financial penalty of 1,000Eur.

In addition, the driver is to write a formal letter of apology to the series and also to ACO and specifically the marshals, as a further apology for his behaviour.

Furthermore, the Stewards will refer the matter to the ASN responsible for issuing the licence to the driver.


