The Stewards notify all Competitors and all Officials of the following:

## 1) Official Timetable

The Stewards approved the Version V4 of the Timetable.

## 2) Pit Stop Reference Time

In accordance with Article 12.4.2 of the 2026 RTLM Supplementary Regulations, the Pit Stop Reference Time for this event is defined as :

**175 seconds**

## 3) Time Penalties

In accordance with Article 7.5.2 of the 2026 RTLM Supplementary Regulations, the time penalty which will be applied in the case of any Drive Through or Stop and Go penalty notified during the last 15 minutes, or after, the race at this competition will be as follows:

(a) Drive Through penalty: will be converted to ~~35~~ **40 seconds** added to the elapsed time of the car.

(b) Stop-and-Go penalty: will be converted to ~~40~~ **45 seconds** plus the prescribed stop time added to the elapsed time of the car.

## 4) Penalty Points

The Stewards notify all competitors and officials that the Points deducted by the Stewards up to the previous event in accordance with Article 7.4.8 of the 2026 RTLM Supplementary Regulations are carried forward to this event as follows:

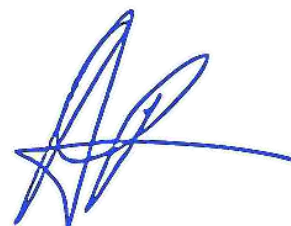
